- 1. Four (4) duly accomplished Reports of Marriage forms (which are available at the Embassy and at the Embassy website).
 - 2. Original and four (4) copies of the British/Irish (with English translation) Marriage Certificate fitted and reduced in size on A4 paper.
 - 3. Four (4) photocopies each of the passports of the husband and wife.
 - 4. The Report of Marriage fee is £23. If the marriage had been solemnized for more than a year prior to the filing of the Report of Marriage, applicants must prepare an affidavit of Delayed Registration of Marriage. The fee of the affidavit is £23. Additional requirements may be required, as circumstances warrant.
